Health Reimbursement Account (HRA)

- **HRA Eligible Expenses** Medical Deductible, Co-Insurance and Prescription Deductible
- **Accessing your HRA**
 - Healthy Dollars will track the employee responsibility with a data feed from BCBS, received weekly. Once the employee responsibility has been met, your card will be activated for RX expenses ONLY.
 - Once your HRA is active, Healthy Dollars will pay your medical providers automatically. Use your Healthy Dollars card to pay for prescriptions.
- **Pro-Rated – No.**
- **Eligibility**
 - Employees working 30+ hours per week are eligible on the 1st of the month following date of hire
 - Employees and eligible dependents must be enrolled in the company sponsored health plan to access HRA funds.
- **Plan Termination:** End of Month - Employees have 3 months from the last day of the month of insurance eligibility to submit claims for payment or reimbursement for services that occurred during plan eligibility.

Flexible Spending Account (FSA)

- Contribution limit \$2,850 (per employee).
- Payroll: Bi-Weekly - 24 Weeks
- \$570 of unused funds will roll into your next plan year's account.

- **Eligibility**
 - Employees working 30+ hours per week are eligible on the 1st of the month following date of hire
- **Plan Termination:** End of Month - Employees have 3 months from the last day of the month of insurance eligibility to submit claims for payment or reimbursement for services that occurred during plan eligibility.

Dependent Care Account (DCA)

- Contribution limit \$5,000 (per family).
- Payroll: Bi-Weekly - 24 Weeks
- Funds are available as they are withdrawn from your paycheck and expenses incurred.
- Daycare, after-school care, summer camps, adult daycare.
- Continual reimbursement 2 business days after payroll available if you are using a consistent provider, such as a daycare or preschool. Please note, summer & vacation camps may not be reimbursed until the camp dates have happened.
- **Eligibility**
 - Employees working 30+ hours per week are eligible on the 1st of the month following date of hire
- **Plan Termination:** End of Month - Employees have 3 months from the last day of the month of insurance eligibility to submit claims for payment or reimbursement for services that occurred during plan eligibility.

Important Plan Notes

- When using your Healthy Dollars card, make sure that all medical and prescription services are submitted through your health insurance carrier and processed before you make a payment with your card.
- Healthy Dollars will issue a card for each employee and their spouse. If you need an additional card for an adult child, please email service@healthydollarsinc.com to request one.
- Cards will be mailed to your home address in separate, non-descript envelopes.
- You do not need a PIN to use your HD card.
- Set up an account online or through the mobile app to check balances and view transactions.

Online Account Instructions

1. To set up your account online go to www.healthydollarsinc.com or download our app which is available on the Apple App Store and the Android Market!
2. Click on "Member Portal".
3. Click on "Register".
4. Select a Username- Usernames must be between 8-12 characters.
5. Choose a password. Passwords must be 8-16 characters and contain 3 of the 4 following types of characters: an upper case letter, a lower case letter, a special character (!,@,#,\$, etc) or a number.
6. Enter your first and last name.
7. Enter your email address.

8. Registration ID: Use the drop- down menu to select Card Number and enter your 16-digit number Healthy Dollars card number into the space provided.
9. Enter your Employee ID: This is your social security number without dashes.
